together with branches if any, has been brought under the purview of the ACT with effect from 1-1-89

The Government of India have since been addressed to issued necessary Notification in the Official Gazette under section 1(4) of the Act extending the provisions of the Employees' Provident Funds Act 1952 and the Scheme framed thereunder to your establishment with effect from 1-1-89 and pending issue of Notification, you are requested to start implementation.

The Code No. allotted to your establishment is AP/18553, which should be quoted invariably in all the correspondence either with the Regional Provident Fund Commissioner or Provident Fund Inspector.

The Scheme shall be implemented from 1-1-89
You have to remit

- (1) Contributions at the rate of ~~8%+6%~~^{8 1/3%} of basic wages, Dearness allowance, cash value of food concession and retaining allowance, if any, in Employees' Provident Fund Account No: I:
- (2) The Administrative charges at the rate of ~~0.37%~~^{0.65%} on the total wages (as above) paid to the subscribers in Employees' Provident Funds Account No:II:
- (3) From and out of ~~8%+6%~~^{8 1/3%} of Provident Fund contributions, a part of contribution representing ~~1 1/2%~~^{1 1/2%} of Employees' share shall be remitted in Account No: X towards Family Pension Fund; and
- (4) 0.5% and ~~0.4%~~^{0.4%} of the total wages shall be remitted in Account No: 21 and 22 respectively towards Employees' contributions and Administrative charges towards the EMPLOYEES' DEPOSIT LINKED INSURANCE SCHEME in the nearest branch of the State Bank of India, Hyderabad.

All the forms prescribed under the Employees' Provident Funds ACT, 1952 and the Scheme are available with the Provident Fund Inspector. None and will be supplied on request free of cost.
